3 POLICY & BYELAWS

GENOMIC SERVICE

Once costs have been finalised Holstein UK will offer a Genomic Test service to its members. **This will be for FEMALES ONLY**. It will be initially offered using a 50K chip. Once a 3K chip is available (expected August/Sept 2010) this will be available as a cheaper alternative with the SNPs imputed to the 50K chip using the US Base.

The GEBV Results will not be published by Holstein UK. The Service will result in animals receiving a GTPI on the US base.

JOINTLY BRED ANIMALS

With effect from 1 January 2011, where a registration is completed with more than one named member as the breeder, the Certificate will be issued to the breeder registering the calf. The Certificate will read 'Jointly Bred'. The animal can have the prefix of the other breeders within its name, but will be subject to a maximum of two names.

ET COLLECTION & MISIDENTIFICATION

With immediate effect all ET Calves will be parentage checked, and internal procedures and those for collection agents will be reviewed.

REPORTING COMBINED MALE PRODUCTION PROOFS

Fact sheets on the website will be amended to read 'Combined Production Proof' where applicable. This will replace the existing statement, 'UK Production Proof'.

NEW MEMBERS

The names of 35 Adult and 14 HYB members were approved.

4 QTR 1 (APRIL – JUNE) ACTIVITIES FIELD SERVICES
